Re. Sanctions against Russia and Belarus in sport

Please find attached to this letter the joint message of the Minister of Education, Science and Sport of the Republic of Lithuania and Lithuanian national sport organisations.

We strongly object to the participation of Russia's and Belarusia's athletes and officials under a neutral flag in international competitions. Those, who benefit from the funding of their governments and participate in competitions organised by their national sports associations cannot in any way be considered neutral.

As long as Russia continues its aggression in Ukraine, we see no possibility for Russians and Belarusians to return to international competitions, and Russian and Belarusian athletes and officials, also – their national and club teams are not welcome in Lithuania.

We also attach Recommendation on cooperation with the Russian Federation and the Republic of Belarus.

We invite you to also choose sides. Remaining "neutral" during this concrete war obviously plays into the hand of aggressor.

DECLARATION

Position of Lithuanian sport associations on the imposition of sport sanctions on Russia and Belarus

15 March 2023

We, the undersigned Lithuanian sport associations and the Ministry of Education, Science and Sport, declare that since the beginning of Russia's aggression against Ukraine on 24 February 2022, we have taken the same position that **Russian and Belarusian athletes must not have the right to participate in any international sports competitions, including qualification for the Olympic Games.**

As a result of the war waged by Russia and supported by Belarus, Ukrainian athletes, unlike Russian and Belarusian ones, have no possibility to train in safe conditions. Ukrainian sports facilities are being destroyed and more than 220 members of the Ukrainian national team have already been killed in the war.

We are outraged by the statement of the International Olympic Committee of 25 January 2023, which contains provisions opening up a pathway for Russian and Belarusian athletes to return to the international sports arenas and to participate in the upcoming Olympic Games, and find it unacceptable.

The intention to return Russian and Belarusian athletes to international competitions under the guise of neutrality is an attempt to justify the aggression that these countries are carrying out in Ukraine and their widely disseminated propaganda, and to use sport as a distraction from their crimes.

We certainly cannot consider such a situation to be in line with the Olympic spirit.

As representatives of the Lithuanian sports community we believe that Russian and Belarusian athletes must not compete under any flag, because athletes, who mostly use the funding from their governments and participate in competitions organised by their national sports associations, can in no way be considered neutral, **and we are therefore opposed to Russian and Belarusian athletes competing under a neutral flag in international competitions and also to their competing in Lithuania.**

In view of the above arguments, we take the position that as long as Russia continues its aggression in Ukraine, we do not see any possibility for Russian and Belarusian athletes to return to international competitions, and that Russian and Belarusian athletes, their national teams and club teams are not welcome in Lithuania.

**Re. RECOMMENDATION ON COOPERATION WITH THE RUSSIAN FEDERATION AND THE
REPUBLIC OF BELARUS**

The Ministry of Education, Science and Sport of the Republic of Lithuania (hereinafter referred to as the 'Ministry') has already informed in its letter No. SR-1011 dated 25 March 2022 that in view of the military aggression of the Russian Federation (hereinafter referred to as the 'RF') and the Republic of Belarus (hereinafter referred to as the 'BR') against Ukraine and the serious violation of international law by such actions, the Ministry recommends to Lithuanian sports organisations to refuse to allow citizens of Russia and Belarus, athletes, administrators and coaches who have **legal** (e.g. have contracts with Russian or Belarusian sports clubs or sports federations), **commercial** (e.g. have promotion contracts with Russian or Belarusian brands or cities that sponsor them) **or public** (e.g. work for Russian or Belarusian state or municipal bodies or companies) and **political relations** (e.g. are members of a Russian or Belarusian political party or members of a power structure (e.g. belong to sports clubs of the Russian or Belarusian armed forces, internal affairs systems, such as 'Dinamo', 'CASK')) with Russian or Belarusian legal entities to participate in international high-performance sport competitions or any other sporting events held in the Republic of Lithuania.

The Ministry's position is unequivocal and has not changed; we hereby therefore urge sports organisations to contribute in all possible ways and actions and to express their position against the Russian war and terrorism being waged in Ukraine and the complicity of Belarusian regime in it.

The Ministry's sports policy strongly advocates and recommends:

1. Not to participate in sports competitions in which athletes and teams from the Russian Federation and the Republic of Belarus representing their countries or participating under white flag are invited and participate. National sports federations that comply with this provision will be funded by the Ministry using the funding model used during the COVID-19 pandemic (the results of previous competitions will be counted).

2. Not to invite or allow participation of citizens of the Russian Federation and the Republic of Belarus representing their countries in sports competitions and events organised in Lithuania.
3. When organising sports competitions in Lithuania, we encourage participants to voluntarily sign a declaration alongside the application form (licence), calling for an end to the war in Ukraine, opposing terrorism and aggression in Ukraine, and expressing opposition to the politics of Russia and Belarus.
4. To call on its international sports federation urging not to allow Russian and Belarusian athletes to compete in World and European Championships and Olympic qualifying events, and to prevent international referees from these countries from officiating at international sporting competitions. Subject to legal/procedural options and after assessing the potential impact, to demand: expulsion or suspension of the Russian Federation and the Republic of Belarus from international organisations, international institutions and other multilateral formats, as well as the expulsion/non-election of the representatives of the Russian Federation and the Republic of Belarus from the governing bodies of international organisations, and the termination of the programmes of international organisations with the Russian Federation and the Republic of Belarus.
5. Not to send invitations and letters of mediation on visa issues to citizens of the Russian Federation and the Republic of Belarus, to contact EU partners requesting that visas not be issued in their countries or that only single-entry visas be issued, and to inform, in the event of direct requests from the embassies of the Russian Federation and the Republic of Belarus in Vilnius, that such correspondence should be channelled only through the Ministry of Foreign Affairs (except in cases provided for in international agreements on consular relations).
6. Not to participate in sports events or competitions of any format organised by the Russian Federation and the Republic of Belarus, including those organised in cooperation with the Russian Federation and the Republic of Belarus, and not to maintain any contacts, and, when participating in multilateral formats, to actively condemn the military aggression of the Russian Federation against Ukraine and the support of the Belarusian regime for this aggression, with the assistance of or through the participation of the representatives of the like-minded countries, and to call for an immediate cessation of military aggression.

The Ministry will initiate the legalisation of these recommendations and their legal implications.

We encourage national sports federations and sports organisations to follow these recommendations, we look forward to your support, and we ask you to make these recommendations known to your members and partners and to encourage compliance.
